

# WILLBOOK ABSTRACTS

## 1872-1936

This book is not only a Record of death but also of life. There are hundreds of names contained within the pages of this book and most of these people at one time lived in McNairy County, Tennessee.

The names of the people written on these pages are long since gone, yet they have left behind a heritage for the people of McNairy County.

These pages tell a story. Tales we will never know. Stories of love and stories of hate.

Most wills were written to include loved ones but occasionally they were written to exclude.

Some were very unusual. Many wills left bedding to specific people. We may find this odd today but a hundred years ago it was considered a luxury to own a feather bed! One man willed his grandson fifteen pounds of feathers and two quilts.

A few wills were different or humorous. One man wanted a "cheap coffin and a big monument." Instructions were left to purchase tombstones from Twelve to Five hundred dollars.

One man wanted a Two hundred dollar monument and One hundred dollars worth of flowers. When his wife died, provided she was buried along side him, would also have flowers, "if not - no flowers from me."

Others tried to rule the living from the grave. One will stated that "if any child deny the Bible, addicted to whiskey or addicted to alcohol," they were barred from the will.


The will of one woman required her husband and three daughters to remain single to benefit from her money.

Wills were written in good health, often many years before dying, others were death-bed wills. A few were oral testimony of the wishes of the deceased. One was a letter written September 25, 1918, on the way to World War I. This will is written in its entirety on the following page.

For many years the date the will was proven was recorded. This practice stopped approximately 1902. Therefore, it is hard to determine the date of death after that time.

This is not the first willbook of McNairy County, Tennessee, but it is the only one that has withstood the stand of time. The first book was lost or destroyed. This book covers the period from approximately 1872 to 1936.

Last will of Albert S. Myrick. Dated September 25, 1918 at Camp Merritt, New Jersey. Now being fitted for overseas duty, waiting to go across to possibly France, during World War I.

Dear Uncle and Aunt

Will now try and right you all a few lines. Am well and trust you all are the same. I am now at Camp Merritt, N. J. Left Camp Wadsworth last Monday, arrived here 25<sup>th</sup>. Am now being fitted out for oversea duty. Don't know when I will go across, may not have to go, don't know yet, but if I do you all don't worry about me for some sweet day I hope to return safely back to you all and I know if it's God will I shall come back to you some time or another.

Had a letter from Anna Bowen and Motlie Whitaker today. They are all well. How is Mrs. Whites folks? Tell them all hello for me and tell sweet little Daisey and Estella I would give anything to see them.

Well Uncle I took out some life insurance and had my policy made to Aunt Agnes. I thought perhaps if I had to go to France it might be of some use to me sometime or the other.

Uncle, you can do what you think best with my mare. Sell her and use the money if you need it. You can sell my cotton and do what you think best with the proceeds. If you need any of the money don't be afraid to use it. You bee sure and don't forget to pay Emmette what I owe him. \$16.00. I got \$15.00 from him the day I left and \$1.00 the day before.

So guess this will be my last time to right to you all for while in the dear old U.S.A.

So hoping to return safely back. I will close and if I should never meeat you all again in this old world of sin and sorrow I hope to meeat you all in a world where sad partings will bee no more.
